

Competition Rules

Promoter:

Illawarra Credit Union (ABN 14 087 650 771, AFSL/Australian Credit Licence 245576) of 38-40 Young Street, Wollongong, New South Wales, Australia; telephone number 13 22 49 (the "Promoter").

Promotional period:

The competition commences on 9:00am AEDT 05/02/2020 and entries close on 11:59pm AEDT 28/02/2020.

Who can enter:

Entry is open to members who have received an email from the Promoter inviting them to complete the survey. Directors and employees of the Promoter, and each of their immediate family members (including de-facto partners and children of those partners), and the retailers, suppliers, associated companies and associated agencies of the Promoter are ineligible to enter.
