

Everyday Promotion T&C's

\$50 Bonus Cash Offer

Terms and Conditions:

1. The person conducting this promotion is Illawarra Credit Union (ABN 14 087 650 771), AFSL and Australian Credit Licence 245576, ("The Promoter").
2. The promotion is open to individuals who do not hold and have not ever held an **Everyday** transaction account (including Everyday, Everyday Student, Everyday Plus).
3. The promotion starts 13 March 2021 at 12:00 am AEDT and ends 30 June 2021 at 11:59pm AEDT (**Promotional Period**).
 - a. To be eligible for both the Cash Bonus, an Everyday account must be opened within the **Promotional Period**.
 - b. There must be an active Visa Debit Card attached to the eligible account.
 - c. Must advise that you're associated with the MS 24hr MegaSwim;
4. To qualify for the bonus promotion, the individual must complete the following **Bonus Conditions** within 45 days of account opening:
 - a. Make a minimum of 3 deposits to the total minimum value of \$500; and
 - b. Make a minimum of 5 Qualifying Transactions.
5. The following conditions must be met in order for a purchase to be a Qualifying Transaction:
 - a. The purchase must be made within 45 days of the **Everyday** account opening;
 - b. Purchase is made at point of sale, online or over the phone using an Illawarra Credit Union Visa Debit Card linked to your Everyday account;
 - c. Purchases must be no less than \$20.00;
 - d. The account must not be in default or overdrawn on the date a purchase is made.
6. The following transactions are excluded from the definition of a Qualifying Transaction:
 - a. Cash advances;
 - b. Cash out transactions;
 - c. ATM withdrawals;
 - d. Pay Anyone payments;
 - e. BPAY payments;
 - f. Transactions that have been cancelled or reversed.
7. Eligible customers will have the \$50 cash bonus deposited into their **Everyday** account within 55 days of account opening, following successful identification verification.
8. The account must remain open during this period in order to be eligible for the offer.
9. The offer is limited to one cash bonus deposit per individual, irrespective of the number of accounts opened.
 - a. If an account with multiple accountholders receives the cash bonus, all accountholders are deemed to have received the bonus.
